Public Hearing – Subdivision application at Governors and Moose Mountain Roads (Tax Map 15, Lot 2)

Mr. Evans started the public comments by inquiring about an updated plat with current conditions for Lot 2, the appropriate wetland scientist stamp, and if the board would conduct a site plan visit. Mr. Keegan expressed concerns about setbacks. Ms. Rigg asked about timing of the subdivision plan.

The Board deliberated and determined they could not proceed approving the application until the plat is updated with current site conditions for Lot 2 and that both sheets are presented to the board in mylar for record keeping with the county registry of deeds.
