

Conservation Commission Meeting Town of Brookfield  
Minutes of June 3, 2009

1. Meeting was called to order at 6:08PM

2. Public Comments: Dick Peckham asked for a new roster of CC members for 09 (Copy Attached).

3. Minutes May 4, 2009: Tom Giguere made a motion to accept the minutes and John Nelson seconded the motion and it passed unanimously.

4. Mail: There was a letter from Bob Bourdeau and a letter from the Jim Seller Law Office to Selectman, cc Planning Board and Conservation Commission representing the interests of Bob Bourdeau requesting that whenever Mr. Bourdeau or his property will be discussed to inform Mr. Bourdeau and his attorney as well as asking for specific information pertaining to site plan reviews and "special event regulations".

5. OLD BUSINESS:

a. New CC Members: See above.

b. Water Withdrawal Hanson Brook: Sang contacted DES about water withdrawal from Hanson Brook and as a consequence it appears that Mr. Bourdeau withdrew his financial support to Moose Mt. Greenways. Mr. Bourdeau has hired an environmental consultant. Installing a pond is under consideration. Tom Welton suggested using stratified drift aquifer concepts. Sang is planning to give a progress report to the planning board. Mr. Bourdeau will be invited to the July meeting of the CC.

d. CC members on subcommittee for Planning Board:

Jennifer and Dick are on the recreational subcommittee. Ms. Coleman will get back to them as to the next meeting.

e. Review Draft Page 5 of NRI updated. Local names for areas will be researched and applied to document. This is an ongoing process. The Pike Brook area was determined to not be a conservation area.

f. HB 235 & HB 385: Tom's letter will be reworded and reviewed at next meeting before being sent to the state reps including the state senator.

g. SRPC GRANITE Update: There has been no communication from GRANITE to indicate the incompleteness of documents as requested.

h. Hike coordinated w/ Old Home Week: It was suggested that we use David

Towle's snow mobile trails as he will be having a miniature train event on his property on August 8, 09 which is Heritage/Farm Day. There is a possibility of a guided tour of several historical sites (stone canal, trotting track, grist mill) on the trails. Sang will be coordinating with Dave on a trail map. David is a tenth generation native of NH therefore he has a lot to offer this community. Jen will research some historical aspects for the walk.

6. NEW BUSINESS:

a. A discussion of timber regulations and lack of enforcement was presented by Dave Towle. This concern was expressed by other members present.

7. Report from Selectman: Ernie Brown will be asked to present an overview of timber regulations. Ernie will be asked to supply the CC with copies of timber cutting intents.

8. Report from Planning Board: They did not have a meeting over Memorial Day and will resume scheduled meetings on 8 June 09.

9. Other business: There was concern regarding crossing wetlands on the Wentworth property on Stoneham Road and Garney Road for a timber cut, but it has been postponed until winter. Also discussed was identifying clear cutting or selective cutting.
