# **Selectmen Notes**

We hope you had a good year and we wish you a happy 2017.

We are pleased to report that the Town has accomplished four major projects this year. With the completion of the eastern side of Stoneham Road, we can finally say that the entire stretch of Stoneham Road has been rebuilt and paved. Included in the Stoneham Road project, new culverts have been installed, the drainage ditch cleaned and the shoulders were rebuilt.

The Town House electric was completely rewired in order to bring the electrical up to code. The wiring was very old, the electrician found that the wiring was not properly grounded and the cotton insulation that wrapped the wiring was beginning to fray, exposing the wires. The Board of Selectmen worked closely with the Heritage Commission in order to ensure this project was completed properly. Lastly, new sconces and chandeliers have been installed providing the much needed, improved lighting for the building.

As you may recall, at the 2016 Town Meeting we were to move forward with the purchase of approximately 250 acres of land in the Town. We have finally closed on that real estate transaction and now we are creating plans for the governance of the land. All input is welcomed as we devise the best way to manage this resource.

Lastly, the Town cemetery is nearly complete and the area looks absolutely beautiful. We would like to thank the Cemetery Trustees for their time and efforts to make sure this project was completed properly and in accordance with the law. The recently planted grass is taking a firm hold before the winter sets in. The Cemetery Trustees are finalizing this project to include some of the finer detail that will allow the Town to appreciate this beautiful resting place for our residents. A vast majority of the work for the Town cemetery is complete and we encourage you to take a drive down Lyford Road.

Projects being considered for 2017 include: addressing the failing Moose Mountain Road Bridge, replacing the roof on the Town Office building, continued road maintenance, and potential future Town House projects.

# **Cemetery Trustees**

The New Brookfield Cemetery, located on Lyford Road, has been completed and is ready for the purchase of Right to Inter plots. The plot map and Cemetery Policies can be found on the Town Website. The purchase price is set at \$500.00 for town residents and \$700.00 for non-residents. The Right to Inter application may be downloaded from the website or is available at the Town Office. The check should be made out to The Trustees of the Trust Fund, Town of Brookfield. The application and check can be dropped off at the town office or mailed to the Cemetery Trustees.

Presently we have 2 sections ready for interments. Future sections will be opened as the need arises. We have a future plan for beautification of the cemetery with trees being planted on both sides of the main cemetery road.

At the top of the hill, the plan is to have a small landscaped area with a flag pole and possibly a Veteran's Memorial. Our hope is to accomplish this in the coming year. An artist rendering of this project will be available on the website in the near future.

# **Supervisors of the Checklist**

By the time you are reading this, we will have completed our fourth election for 2016. The Presidential Primary was held on Feb. 9. For this election, 354 residents voted in this election, 69% of the registered voters, 120 as Democrats and 234 as Republicans. The Town elections were held on Mar. 8. 102 residents voted at the polls and 59 attended Town Meeting. Next, we held the State Primary election on Sept. 13. 170 residents voted in this primary, comprising 33% of the registered voters, with 49 residents voting in the Democratic Primary and 121 in the Republican. The state and federal General Election was held on Nov. 8. Results for this election will be recorded in the annual Town Report.

Residents may register to vote in Brookfield with the Town Clerk during her regular office hours, at any meeting of the Supervisors of the Checklist, or during any election. Supervisor meetings are posted on the calendar on the Brookfield website (<u>www.brookfieldnh.org</u>), in the Granite State News, and on the notice boards in front of the Town Office and at Stoneham Corners.

# Emergency care files update:

Residents are responsible to advise the county sheriff's office (539-2284) and Wakefield Fire Department of any special circumstances that those responding would need to be aware of. Call the Wakefield Fire Department's non-emergency number (522-3232) to list anyone who is on a life support ventilator, uses an oxygen system or any other type of life support system that runs on electricity, is bedridden and would need to be moved in the event of power failure, or lives alone and may need to be checked on in the event of power failure.

**Severe Emergencies:** In case of extended power outages or other emergencies, the Town House will be open to provide water, cooking facilities, and shelter to residents in need. Please contact the Selectmen for access.

**Dog licenses** must be renewed by April 30 or a civil forfeiture fine of \$25.00 will be incurred in addition to a late fee of one dollar a month. Renewal forms will be available starting January 1<sub>st</sub>. Rabies shots must be current. Bring a rabies certificate from your veterinarian as proof. See the Town Clerk for new licenses.

**You are reminded** that injury or destruction of any cemetery or burial ground including monuments, tombs, fences, gates, and other structures is a felony. RSA 635.6

**Intent to Cut** and **Intent to Excavate** forms must be signed by the Selectmen and filed with the Code Enforcement Officer before work begins. Get applications from Ed Nason, our Code Enforcement Officer.

**Town Driveway Permits** are mandatory when putting in a driveway accessing a town road. Apply to the Code Enforcement Officer. State permits are required for accessing state roads.

Protect our town from forest fire! Get permits from our fire warden, Brad Williamson, 522-6018, for all open burning you plan.
