Members of the Board and the public asked questions about the survey process and findings. Mr. Varney detailed his process and provided context on his findings. Susan Marquis made several comments unrelated to the subject matter and complained about culvert installations along Lyford Road. There was discussion around the 5 acre lot and its driveway access and home placement. The Board discussed several action items; NHDOT driveway access off Lyford Rd., request for square footage of building area on 5 acre lot, questions about driveway access on Wentworth Road, and any comments from the Wakefield Water District.
