Planning Board Meeting Minutes Monday, January 09th 2023 APPROVED

Call to Order.

The meeting was called to order at 7:00 PM

 - Mr. Straz read the amendment aloud, stating the rationale is to correct the missing "approved" to private roads and to have lot access on the 250' of frontage. Public comment: Mr. Evans asked about the definition of a private road.
- Amendment No. 2 Amend Zoning Ordinance Ra-1, 2i
 - Mr. Straz read the amendment aloud, stating the rationale is to align with setback requirements for right-of-way and wet areas. Public Comment: Mrs Buell asked about setbacks.
- Amendment No. 3 Repeal Article II, 2 and Appendix E
 - Mr. Straz read the amendment aloud, stating the rationale is to update to a permissive ordinance. Public comment: Mr. Lofgren asked about the list.
- Amendment No. 4 Amend Zoning Ordinance, RA-1, 3d
 - Mr. Straz read the amendment aloud, stating the rationale is to support the building inspector to manage ancillary structures. Public comment: none.
- Amendment No. 5 Rewrite Zoning Ordinance, RA-1, 1b
 - Mr. Straz read the amendment aloud, stating the rationale is to update and create a method for Selectmen to administer a permit system. Public comment: Mr. Evans asked about the permit process and suggested the planning board creates a document defining this process.
- Amendment No. 6 Redefine Article X.B from Accessory Building to Ancillary Structure
 - Mr. Straz read the amendment aloud, stating the rationale is to support the building inspector to manage ancillary structures. Public comment: none.
- Amendment No. 7 Add viii & ix to RA-1 1.d ADUs
 - Mr. Straz read the amendment aloud, stating the rationale is to update and better define the footprint of an ADU and type. Public comment: Mr. Comeau disagrees with the 30%
