


Brookfield Master Plan Survey 2018 - Results

These results are based on a survey conducted between July 19 and October 18, 2018. There were 114 respondents.








Promotion of areas for commercial business to increase the tax base and lower taxes on residential properties


We already have enough restrictions on building development, etc. Restricting homeowners as to what color they can paint their houses or house design ala historic district is infringing on their rights. Too much regulation












24. Brookfield essentially has one district zoning as Residential/Agricultural. Going forward, which method would you like to see Brookfield follow? (Please mark one)




25. Which of the following types of residential development would you like to see more of in Brookfield? (Mark all that apply.)




26. What pattern of commercial/business development would you prefer to see in Brookfield?








