PUBLIC NUISANCE ABATEMENT ORDINANCE UNNECESSARY NOISE

- L:A Land Vehicles. No person shall operate any vehicle in the Town of Brookfield so as to make any loud, unusual or other unnecessary noise as hereafter defined:

 1:B DEFINITIONS
 - a. The word "Vehicle" whenever used in section 1:A shall include all vehicles as defined by New Hampshire Revised Statutes Annotated, 1955, as amended.

b. The word "street" whenever used in section 1:A shall include crosswalk, intersection way or other public way as defined by New Hampshire Revised Statutes Annotated, 1955, as amended C. 259 section 1.

- c. The words "Loud, unusual, or other unnecessary noise" whenever used in section 1:A shall include any noise occasioned by any one or more of the actions of the operator of any vehicle as defined in the following Section 1:C Misuse.
- 1:C MISUSE
 - a. Misuse of power exceeding tire traction limits in acceleration some times known as "Laying down rubber" or "Peeling Rubber" or
 - b. Misuse of breaking power exceeding tire traction limits in deceleration where there is no emergency,
 - c. Rapid acceleration by means of quick upshifting of transmission gears with either a clutch and manual transmission or an automatic transmission.
 - d. Rapid deceleration by means of quick downshifting of transmission gears with either a clutch and manual transmission or an automatic transmission.
 - e. Racing of engines by manipulation of the accelerator gas pedal, carburator, or gear selector whether the vehicle is either in motion or standing still;
 - f. The blowing of any horn except as a warning signal or the use of any other noise making device whether the vehicle is either in motion or standing still.

 GENERAL REGULATIONS
- 2:A ALCOHOLIC BEVERAGES
 The consumption of alcoholic beverage is prohibited on all property over which the Town has supervision and or control. The penalty for each offence shall be no less than \$10.00 nor more than \$50.00.
- 2:B GENERAL PENALTY
 Except as otherwise herein provided, any person convicted of a violation of any provision of this ordinance shall be fined not more than \$50.00 each offence:
- 2:C All fines collected under the provision of these regulations shall insure to the General Fund of the Town of Brookfield:
- 2:D This ordinance is effective May 3, 1979

ORDINANCE REGULATING VEHICLE WEIGHTS UPON THE PUBLIC STREETS OF THE TOWN OF BROOKFIELD, NEW HAMPSHIRE

AUTHORITY: RSA 41:11

IT BEING SHOWN THAT IN ORDER TO PROTECT THE ROADS FROM THE ADVERSE EFFECT AND DAMAGE CAUSED BY CERTAIN VEHICULAR TRAFFIC, IT SHALL BE NECESSARY FROM TIME TO TIME TO LIMIT THE MAXIMUM ALLOWABLE WEIGHT OF ANY VEHICLE TRAVELING UPON THE ROADS OF THE TOWN OF BROOKFIELD. THE BROOKFIELD ROAD AGENT IS HEREBY AUTHORIZED TO POST A MAXIMUM WEIGHT LIMIT FOR ANY VEHICLE TRAVELING ON A TOWN ROAD LOCATED WITHIN THE TOWN OF BROOKFIELD. SAID WEIGHT LIMITS AND THE APPLICABILITY OF SAID LIMITS TO ANY PARTICULAR ROAD LOCATED WITHIN SAID TOWN MAY CHANGE FROM TIME TO TIME WITHIN THE DISCRETION OF SAID ROAD AGENT. THE EFFECTIVE DATE OF ANY CHANGE IN WEIGHT LIMIT SHALL BE AS OF THE DATE OF POSTING OF SAID WEIGHT LIMIT.

THIS ORDINANCE IS EFFECTIVE IMMEDIATELY AND SHALL REMAIN IN EFFECT UNTIL SUCH TIME AS IT MAY BE RESCINDED BY THE SELECTMEN.
